The undersigned Applicant, having previously been approved for a Temporary License by the Tennessee Board of Law Examiners under Tenn. Sup. Ct. Rule 7, Section 10.06, respectfully requests a one-year extension of the Temporary License under § 10.06(c)(2)(A). In support of this Application for Extension, Applicant swears or affirms as follows:

1. I am the Spouse of an active duty servicemember of the United States Uniformed Services and that servicemember is on military orders stationed in the State of Tennessee or Fort Campbell, Kentucky.
2. I am currently physically residing in Tennessee or Fort Campbell, Kentucky, due to the military servicemember's orders and if I have moved within Tennessee or Ft. Campbell, KY, while temporarily licensed in Tennessee, I have provided the Board with my updated address.
3. I am licensed and admitted by examination to practice law before the court of last resort of _____ (name of state or states).
4. I am currently an active member in good standing in every jurisdiction to which I have been admitted to practice or have resigned or been administratively revoked while in good standing from every jurisdiction without any pending disciplinary actions.
5. I am not currently subject to lawyer discipline in any other jurisdiction.
6. I have paid the fee set by the Board and Court for this Application.
7. There have have not been changes to my Application which require additional explanation for my application to be complete and accurate. (Please attach a description of any changes, identifying the question number from the NCBE application and attaching additional pages, as needed, to fully amend your response).
8. Attached to this application are the following:
 - a. a certificate of good standing from the highest court in each state in which I am licensed;
 - b. a copy of my Military Spouse Dependent Identification;
 - c. documentation evidencing a spousal relationship with the servicemember; and
 - d. a copy of the servicemember's military orders to a military installation in Tennessee or Fort Campbell, Kentucky, or a letter from the servicemember's command verifying that the requirement in Paragraph (a)(8) of Section 10.06 is met.

By signing below, I swear or affirm that the statements above and all supplementary information attached is correct to the best of my knowledge. I understand that I have a continuing duty to keep my application current and I agree to notify the Tennessee Board of Law Examiners of any changes or additions to my responses to the NCBE application or the TBLE application to the information when the information previously provided changes. I understand that failure to respond fully, accurately and truthfully to the questions included on the NCBE or TBLE applications may result in denial of my application to practice law in Tennessee.
